ARTICLES OF INCORPORATION

<u>OF</u>

PONDEROSA PROPERTIES, INC.

ARTICLE I - NAME:

The name of this corporation is Ponderosa Properties, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing on the date set forth below (i.e., the date of subscription and acknowledgment of these Articles of Incorporation).

ARTICLE III - PURPOSE:
