ARTICLES OF INCORPORATION

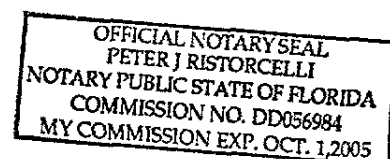
