ARTICLES OF INCORPORATION OF

RESIDENTIAL FIRE SPRINKLER SYSTEMS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be RESIDENTIAL FIRE SPRINKLER SYSTEMS, INC.

ARTICLE II PRINCIPAL OFFICE

Failure of the Directors to act upon such a proposal within sixty days after receipt thereof shall be deemed to consent by them to the proposed transfer. No such proposed transfer shall be made until the aforesaid sixty (60) days have expired or the Board of Directors has consented thereto.
