2. That the Corporation was administratively dissolved by the Florida Department of State on 1 October 2004.

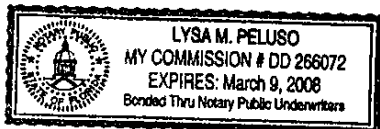
