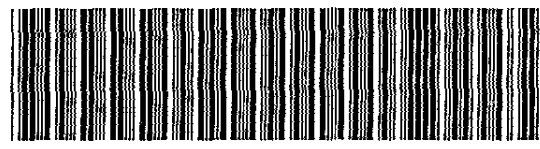

ARTICLE I - NAME

The name of this corporation is VICKEN INTERNATIONAL GROUP, INC.

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.


**ARTICLE XI - AMENDMENT**




