ARTICLE I - NAME

The name of this corporation is HUGH JENKINS CONTRACTOR, INC.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE


