

Article I - Name

The name of this corporation is **MURNANE ENTERPRISES**, **INC.** The mailing address for the corporation is 1132 S. Main Street, Gainesville, Florida 32601.

Article II - Duration

This corporation shall have a perpetual existence, commencing on the date of filing these articles with the Department of State.

Article III - Purpose
