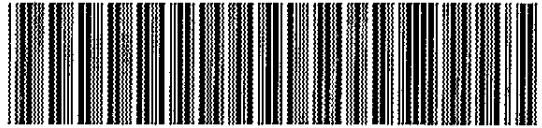

The Name of the Corporation is S & S CLEANING AND PAINTING, INC.




