ARTICLES OF INCORPORATION

I, the undersigned, being of legal age and natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I

DI-OI-OF

The name of this corporation is SABAL REALTY, INC.
This Corporation is to be effective as of Jan. 1=, 2004

ARTICLE II PURPOSE
