ARTICLE 1. - NAME

The name of the Corporation is RTA Tile, Inc..

# **ARTICLE 2. - PRINCIPAL OFFICE**

The principal office of the Corporation shall initially be at 725 North Conrad Avenue, Sarasota, Florida 34237-4627. The Corporation may change its principal office from time to time as permitted by law.
