ARTICLES OF INCORPORATION
OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is: DSM PROPERTIES, INC.

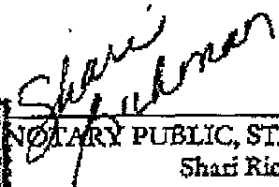
