The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I: NAME

The name of the corporation shall be Kevin Wright Enterprises, Inc.

#### ARTICLE II: NATURE OF BUSINESS \_
