**ARTICLES OF INCORPORATION  
OF  
LARGE ANIMAL VETERINARIAN SERVICES OF CENTRAL FLORIDA, P. A.**

The undersigned incorporator, WILLIAM ALLEN PRIVETTE, D.V.M., for the purpose of forming a professional corporation pursuant to the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation.

**ARTICLE 1. NAME**

The name of the corporation is LARGE ANIMAL VETERINARIAN SERVICES OF CENTRAL FLORIDA, P. A. (the "Corporation").

**ARTICLE 2. PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office of the Corporation is 4208 Sunny Brook Way, Winter Springs, Florida 32708. The mailing address of the Corporation is 5703 Red Bug Lake Road, Box 317, Winter Springs, Florida 32708.

**ARTICLE 3. CAPITAL STOCK**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock with a par value of \$1.00 per share. The authorized shares of the Corporation shall consist of one class of common stock only.

**ARTICLE 4. PREEMPTIVE RIGHTS**

The Corporation elects to have preemptive rights.
