Dear Division of Corporations Representative,

I am writing you to explain the reason why I am sending you this Profit Report Form late.

Your office sent me a card to apply for a Profit Report Form several months ago (before May 1st). I mailed that card back to you the same day that I received it. The card said to "allow 10-14 days" for delivery of the Profit Report Form. I never received it.

In late June, your office sent me a Notice of Intent to Dissolve/Application for a Profit Report Form again. I mailed it back to you right away. I received a Profit Report Form a couple of weeks ago. However, it stated that I owed a \$400 late fee for not filing the form before May 1st.

This is my first year as a corporation in Florida. I did not know about the deadline or the \$400 late fee because I wasn't sent the Profit Report Form until July. If I had received a Report Form before May 1st, I would have filed it in a timely manner.

Therefore, I called and spoke to one of your Customer Service Representatives, who recommended that I send in a letter explaining my situation/circumstances and request that you waive the \$400 late fee.
