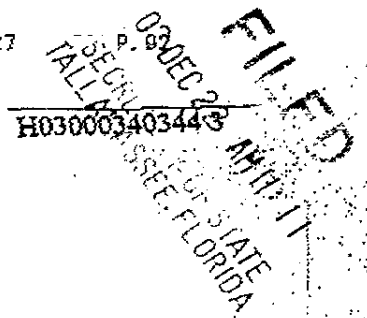


**ARTICLES OF INCORPORATION****OF****Midtown Celluar FL Inc.**
