ARTICLES OF INCORPORATION OF TRIAGE MANAGEMENT SERVICES, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS
