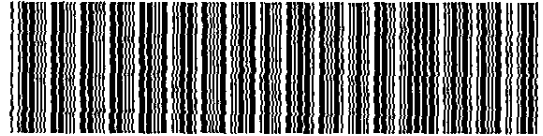

ARTICLES OF INCORPORATION

OF

ARTICLE I. CORPORATE NAME.

The name of this Corporation is: BRISBANE FLOORING, INC.

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.
