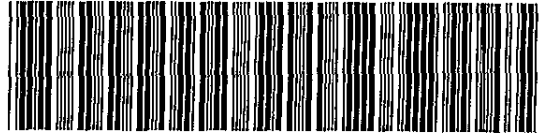

The undersigned, who is duly licensed to do business in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be DRAGON FORCE FRAMING, INC.

ARTICLE II - PURPOSE

The purpose for which the Corporation is organized is for any lawful purpose.

ARTICLE III - DURATION

This Corporation shall exist perpetually, commencing on the date of filing the Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK

The number of shares of stock that the Corporation is authorized to have outstanding is 7,000, all of which shall be common shares with a par value of \$1.00.
