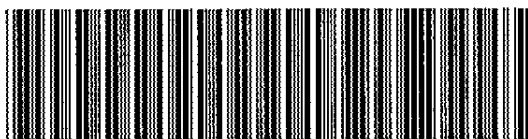

ARTICLES OF INCORPORATION

OF

BILCAM INVESTMENTS, INC.

ARTICLE I - NAME

The name of this Corporation is BILCAM INVESTMENTS , INC.

ARTICLE II - DURATION





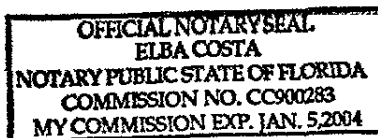
