The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

**Name:** The name of the corporation is Ervin D. Smith Construction Company, Inc.

**Address of Principal Office:** The address of the principal office of the corporation is 39172 Waters Edge Drive, Hilliard, Florida 32046.

ARTICLE II

DURATION

This corporation shall exist perpetually. ARTICLE III

PURPOSES
