ARTICLES OF INCORPORATION
OF
CRAY WELL DRILLING & PUMP SERVICE, INC.

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be CRAY WELL DRILLING & PUMP SERVICE, INC., with its principal place of business at 1481 Southeast 80th Street, Ocala, Florida 34480.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00).

ARTICLE IV - PRE-EMPTIVE RIGHTS

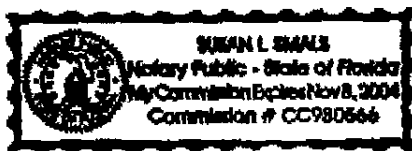
