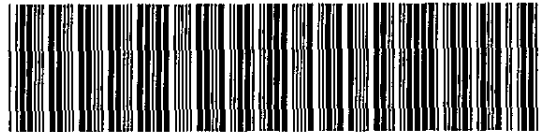

**ARTICLES OF AMENDMENT
