ARTICLES OF INCORPORATION OF KNOXVILLE MINT, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I NAME AND ADDRESS

Section 1.1. Name. The name of the corporation is Knoxville MINT, Inc.

Section 1.2. Address of Principal Office. The address of the principal office of the corporation is 6960 Bonneval Road, Suite 102, Jacksonville, Florida 32202.

ARTICLE II DURATION

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually. Corporate existence shall commence at 12:01 a.m. on January 1, 2004.

ARTICLE III PURPOSES

EFFECTIVE DATE

Section 3.1. <u>Purposes</u>. This corporation is organized for the purposes of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV CAPITAL

Section 4.1. <u>Authorized Capital</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 50,000 shares of voting common stock having a par value of \$1.00 per share.
