In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby adopts and files the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ANDREWS' MANAGEMENT SERVICES, INC.

ARTICLE II

The existence of the Corporation shall begin on 1 January 2004.

ARTICLE III
