The above referenced entity was organized around February of this year, 2004. I was shocked and taken by complete surprise when I received the "Notice of Dissolution or Revocation" a few days ago.

While still in a state of shock and bewilderment, I called your office to find out what was going on. An extremely courteous personnel took my call, listened to me for a while, then advised me very calmly to "write a letter of explanation" to you, requesting the wavier of the "Penalty Fee" of \$500.00.

I am very grateful for the suggestion, and for the fact that you are willing to waive this penalty. And I will endeavor to be brief in my "explanation".

- 1. I am a senior, 70 years +, and just have not adopted well to technology. Therefore, when informed "you could/should have downloaded the form from the Web site", that is a process I did not anticipate, done before, nor would be relying on, when it relates to matters of critical importance. I use my computer simply as a "Word Processor".
- 2. I do have an expensive computer system-I paid over \$3,500 for it a few years ago, but I purchased it just to write my Theses and Dissertation; the e-mail and web site I am paying for have not worked for more than a year now.
- 3. I anticipated receiving "Renewal" and "Report" forms the traditional way-via U. S. Postal Service. Neither did I expect to "Renew" an entity that is not a year old, as yet.
- 4. Because of <u>bad professional financial advice</u>, I now 'exist' on a small Social Security payment, (I never thought I would need Social Security, much more to rely on it) plus any additional income I can earn from the many diplomas, degrees, and expertise I acquired over the years. I just cannot afford a \$500 penalty fee, on my budget. I have not began to earn any income through this corporation, as yet.
- 5. Please notify me using the traditional means-U.S. Postal Service-when the time comes for "Renewal" and "Reports".
- 6. Enclosed is the completed "Renewal Form" and the \$150 I was told would be sufficient, subject to your "consideration".
