The undersigned incorporator, for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby files these Articles of Incorporation:

ARTICLE I -- NAME

**ARTICLE X -- EFFECTIVE DATE**


