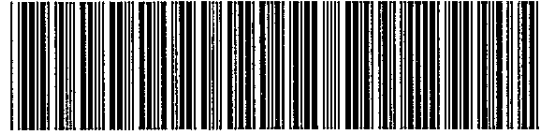



ARTICLE I - NAME

The name of the Corporation shall be CHARLES W. SUFFIELD, INC.

ARTICLE II - EXISTENCE

The Corporation shall have perpetual existence and its existence shall begin business upon the approval of these Articles of Incorporation by the Secretary of State.

ARTICLE III - BUSINESS

The primary purpose of the Corporation is to provide contracting related services. However, it shall be permissible to engage in any business or service allowable under the laws of the State of Florida and the United States of America.

ARTICLE IV - STOCK

The Corporation shall be authorized to issue One Hundred (100) shares of stock which shall have no par value.


