The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: USATies, Inc. The principal office of the Corporation is 2015 Stone Abbey Boulevard, Suite 3, Orlando, Florida 32825. The mailing address of the Corporation is 2015 Stone Abbey Boulevard, Suite 3, Orlando, Florida 32825.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
