## ARTICLES OF INCORPORATION

OF

### PARAMOUNT STONE, INC.

In compliance with the requirements of Chapter 607 and/or Chapter 621, F.S., the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles for the purpose of organizing a business corporation.

#### ARTICLE I

The name of the Corporation ("Corporation") is: **Paramount Stone, Inc.**

#### ARTICLE II

The street address of the principal of the Corporation is:

#### ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 20,000, par value \$1.00 per share, all of which shall be Common Shares. 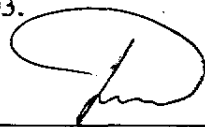
