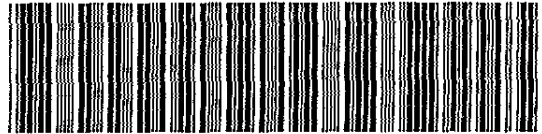



**ARTICLE I - NAME**

The name of this Corporation shall be:

#### ARTICLE IX - AMENDMENT




