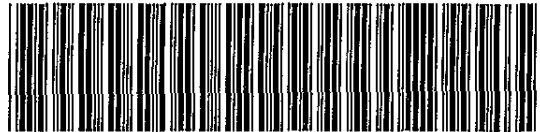

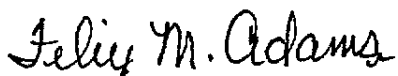

CORPORATE NAME.**
