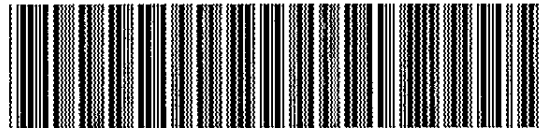

ARTICLES OF INCORPORATION

OF

ALLIED LAWN EQUIPMENT, INC.

THE UNDERSIGNED, acting as the sole incorporator of Allied Lawn Equipment, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

Article I

Name

The name of the corporation is Allied Lawn Equipment, Inc.

Article II

Effective Date

The effective date of the corporation shall be the date these articles are filed.

Article III

Shares

The number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000), One Dollar (\$1.00) par value per share. In the event that stock other than common is issued, compliance with Florida Statutes, Section 607.0602 will be observed.
