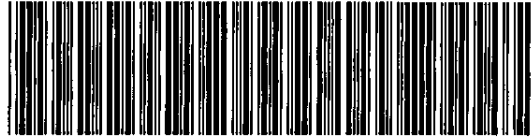


ARTICLES OF DISSOLUTION

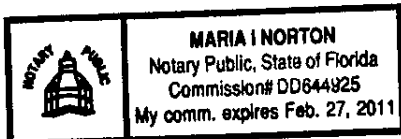
