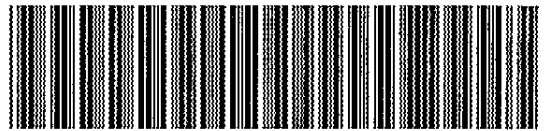

Indemnification

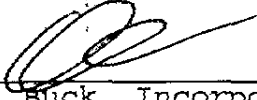

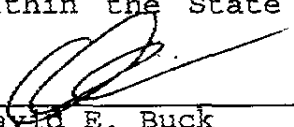
