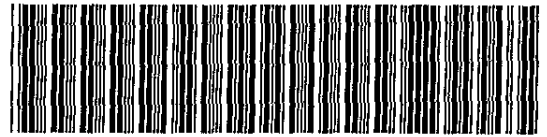

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. **NAME.** The name of the corporation is **AHRENS OF S.W. FLORIDA, INC.**
2. **TERM.** This corporation shall exist perpetually.

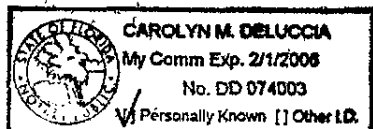
