ARTICLES OF INCORPORATION OF JOHN SVADBIK, P.A.

I, the undersigned, desiring to form a corporation for the purposes hereinafter stated, under and pursuant to Chapter 607 of the Florida Statutes, do hereby declare as follows:

ARTICLE 1 NAME

The name of the corporation shall be: JOHN SVADBIK, P.A.

ARTICLE II NATURE OF BUSINESS

The corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States and of the State of Florida or any other state, country, territory or nation. The specific purpose is real estate activities.
