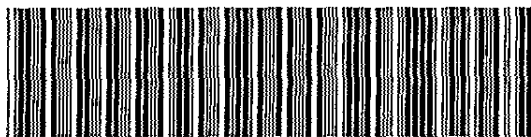



ARTICLE V - INCORPORATOR


