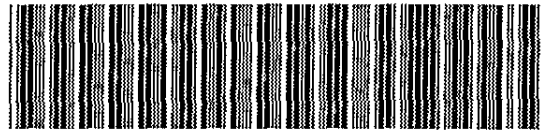

ARTICLE ONE: The name of this Corporation shall be J. JONES
WALLCOVERINGS, INC.

ARTICLE TWO: The existence of the Corporation shall be perpetual.

ARTICLE THREE: The nature of the business and the objects and purposes to be transacted, promoted and carried on are to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.

ARTICLE FOUR: The amount of total capital stock of the Corporation shall be divided into 100 shares with one dollar par value.

ARTICLE EIGHT: The name and address of the person signing these Articles of Incorporation as Incorporator is Jamie P. Pearson.

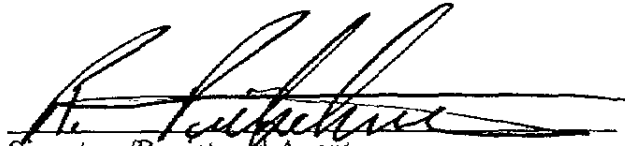
ARTICLE NINE: All of the Corporation's Authorized Capital Stock will be one class "Common Stock".
