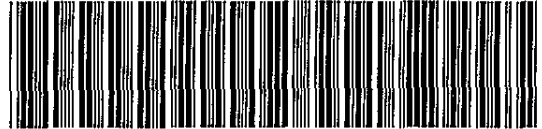

ARTICLE I - NAME

The name of this Corporation shall be:

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT


