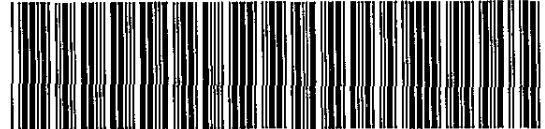

ARTICLE VII



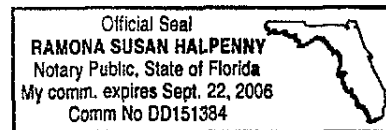
