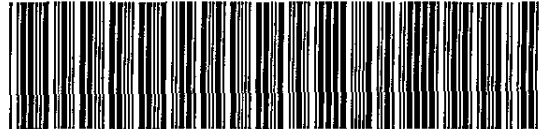

ARTICLE I**

NAME

The name of this Corporation is **1ST QUALITY CLEANING, INC.**
