ARTICLES OF INCORPORATION

OF

STEVE'S FLOORING, INC.

ARTICLE I

The name of this corporation shall be STEVE'S FLOORING, INC., and its principal address is 1548 Debonair Drive, Holiday, FL 34690.

ARTICLE II

This corporation shall have perpetual existence which shall commence at the time of the filing of these Articles of Incorporation with the Department of State.
