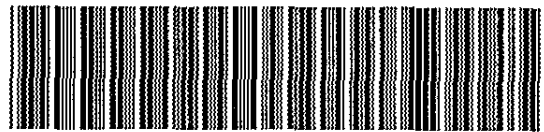


## ARTICLE ELEVEN
