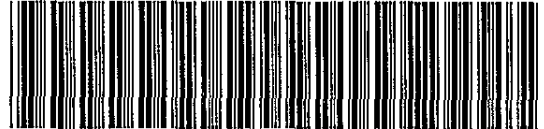

**ARTICLES OF INCORPORATION  
OF  
BUTCH'S HOME REPAIR, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is Butch's Home Repair, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is 2713 Cranmoor Drive, Kissimmee, Florida 34758.

**ARTICLE III**

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.


