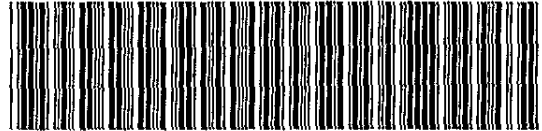



The Initial Director of the corporation shall be James Carnley, 4050 Florida Town Road, Pace, Florida 32571.



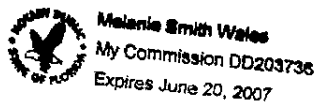


