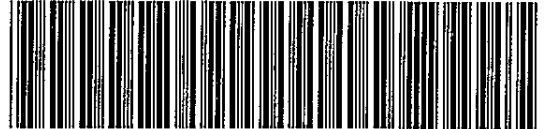

**By Christmas of 2003 I still had no word on my filing for incorporation. However, our discussions had made me decide that I should not enter into this business.**


