- 1. This following plan of merger is submitted in compliance with section 607.1101, Florida Statutes, and in accordance with section 55-11-01 of the North Carolina General Statutes.
- 2. The name and jurisdiction of surviving corporation is Aerial Cartographics of America, Inc., a Florida corporation.
- 3. The name and jurisdiction of merging corporation is Independent Mapping Consultants, Inc., a North Carolina corporation.
  - 4. The effective date of the merger will be June 30, 2017.
- 5. On the effective date of the merger, the constituent corporations shall be merged into a singe corporation, Aerial Cartographics of America, Inc., existing under the laws of the State of Florida.
