#### ARTICLE XII - SHAREHOLDER AGREEMENT

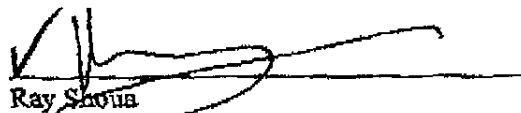
The shareholders of this corporation may at any time from time to time enter into shareholder agreements not inconsistent with the powers of authority conferred by law, but including provisions

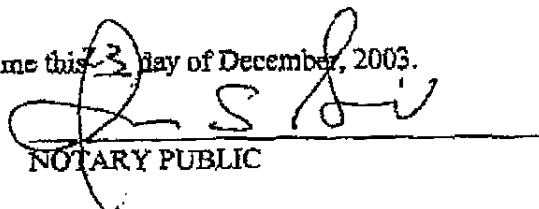

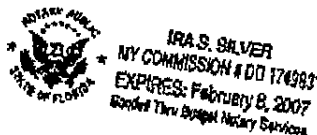

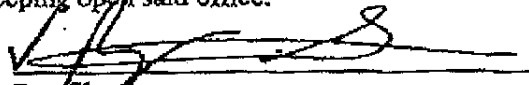
