## ARTICLES OF INCORPORATION OF

### A-ROCC TILE CREATIONS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### ARTICLE I

The name of the Corporation ("Corporation") is A-ROCC TILE CREATIONS, INC.

The existence of the Corporation shall begin on January 1, 2004
