ARTICLES OF INCORPORATION OF SUZANNE M. MAILLOUX, PA

ARTICLE I_NAME

The name of this Corporation is Suzanne M. Mailloux, PA

ARTICLE II - EFFECTIVE DATE

This Corporation shall be effective on January 1, 2004.

ARTICLE III - ADDRESS

The principal office location and the mailing address of the Corporation is 220 East Forsyth Street, South Suite, Jacksonville, Florida 32202.

<u>ARTICLE IV - NATURE OF BUSINESS</u>

The general nature of the business to be transacted by this Professional Service Corporation is:

To engage in every phase and aspect of the business of rendering professional services to the public that an attorney is authorized to render under the laws of the State of Florida. However, no professional services shall be rendered by this Corporation except through its officers, employees, and agents who are duly certified, registered or licensed or otherwise legally authorized to render such professional services within this State.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of this Corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this Corporation otherwise permitted by law.

The general nature of the business to be transacted by this Professional Service Corporation as described in this Article is intended to comply with Florida Statutes Section 621.08

ARTICLE V - CAPITAL STOCK

(a) <u>Authorized Shares</u>. This Corporation is authorized to issue 10,000 shares of common stock, all of which shall be of the par value of \$.01 per share. Each of the shares of common stock shall entitle the holder thereof to one (1) vote at any meeting of

the shareholders. All or any part of the common stock may be paid for at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be fully paid and nonassessable.

- (b) Preemptive Rights. Shareholders shall have no preemptive rights.
- (c) Cumulative Voting. Cumulative voting shall not be permitted.
- (d) Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this Corporation as they may see fit.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 220 East Forsyth Street, South Suite, Jacksonville, Florida 32202 and the name of its initial registered agent at such address is Suzanne M. Mailloux.

ARTICLE VII - INCORPORATOR

ARTICLE VIII - DIRECTORS

- (a) <u>Number</u>. The Corporation shall initially have one (1) director. The number of directors may be changed from time to time in accordance with the bylaws of this Corporation.
- (b) <u>Compensation</u>. The Board of Directors is herby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be
